The CCDF Child Care Program assists low-income families, families receiving temporary public assistance and those transitioning from public assistance in obtaining child care so they can work. CCDF funds are also used for Quality activities to improve the quality of child care by financially assisting child care providers in their professional development and maintaining healthy, safe, appropriate learning environments for children 0 to 12 years of age.

States use CCDF to provide financial assistance to low-income families to access child care so they can work or attend a job training or educational program.

The Child Care and Development Fund program, or as it is referred to, CCDF, is distributed on a yearly basis to all federally recognized tribal grantees and Tribal Lead Agencies, such as California Rural Indian Health Board, Inc. This program is federally funded, subjected to federal regulations governing this program.

The Child Care and Development Fund (CCDF) provided states more than \$8 billion in federal funds in fiscal year 2019. The Office of Child Care (OCC) oversees the integrity of the CCDF, which subsidizes child care for low-income families. A key part of OCC's oversight includes reviewing and approving State Plans.
